Hunters may not hunt within 100 yards of residential areas and golf course.

TURKEY HUNTERS

Please be sure of your TARGET before you pull the trigger. Remember, turkeys and people sound alike walking in the woods and there are other hunters out there making turkey calls.

BE SAFE - BE SURE - NOT SORRY!

CAUTION:

- * IT IS A VIOLATION OF STATE LAW TO SHOOT FROM OR ACROSS ANY ROAD AND IS VERY DANGEROUS BECAUSE OF THE HIGH VOLUME OF PEDESTRIAN, BICYCLE, AND VEHICULAR TRAFFIC IN THE OAK RIDGE AREA.
- * GUN HUNTERS MAY NOT HUNT WITHIN 100 YARDS OF RESIDENTIAL AREAS, INDUSTRIAL FACILITIES, AND PARKING LOTS.
- * RECOMMENDED MAXIMUM SAFE SPEED OFF ROAD IS 15 MILES PER HOUR. YOUR SAFETY IS YOUR RESPONSIBILITY.

Shotgun/Archery. Hunters accessing this area must possess ORWMA Permit AND DOE Badge.

(Badges accepted = Blue-Q, Yellow-L, Gray-U, Green-Reservation Specific, White-HSPD-12)

Must check in & out at intersection of Melton Valley Access Rd./Ramsey Dr.
