

SUBJECT: DISCUSSION OF SMALL CELL ORDINANCE AT JULY 16, 2019

For several months members of staff have been working to develop an approach to rights of way use, and in particular Small Cell Installations. 

SUBJECT: TVA PRESENTATION AT JULY 16, 2019 WORK SESSION

TVA is requesting time to make a presentation to the City Council at the July 16 work session to review plans relative to a new electric substation inside of the City limits of Oak Ridge. The station is planned to be located on TVA owned property between Haw Ridge Park and Edgemoor Road.

The presentation will be made by Rockey D. Hall, TVA Manager, Customer Planning, and Jeff Powell, Senior Program Manager, Bulk Transmission Planning, with support from other TVA staff.

The purpose of the presentation will be to outline the need for the new substation, its location, possible impacts, and alterations required to transmission lines in the area.
